

Healthcare Sector Update



Summary – Healthcare Services

- The S&P Healthcare Services Index has increased by 9.3% over the last three months, outperforming the S&P 500 (4.5% increase over the last three months).
- Over the past three months:
 - > The best performing sectors were Emergency Services (up 55.9%) and Psychiatric Hospitals (up 18.6%)
 - > The worst performing sectors were Specialty Managed Care (down 12.7%) and Healthcare REITs (down 10.8%)
- The current median LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 1.74x and 12.9x, respectively.
- The sectors with the highest valuation multiples include:
 - > HCIT (3.54x LTM Revenue, 22.3x LTM EBITDA)
 - > Emergency Services (2.80x LTM Revenue, 27.9x LTM EBITDA)
 - > Consumer Directed Health and Wellness (3.18x LTM Revenue, 20.0x LTM EBITDA)

Summary – Pharmaceutical / Medical Devices / Life Sciences

- The S&P 500 – Pharmaceuticals, Biotechnology and Life Sciences Index has risen 2.3% over the last three months, underperforming the S&P 500 (4.5% increase over the last three months).
- Over the past three months:
 - > The best performing sectors were Ophthalmology Devices (up 17.8%), Mobility Devices (up 17.6%) and Life Science Consumables (up 9.9%)
 - > The worst performing sectors were Biotechnology (down 3.0%) and Lab Equipment (down 3.0%)
- The current median LTM revenue and LTM EBITDA multiples for the Pharmaceutical / Medical Device / Life Science industry overall are 3.38x and 15.0x, respectively.
- The sectors with the highest valuation multiples include:
 - > Biotechnology (8.06x LTM Revenue, 15.0x LTM EBITDA)
 - > Pharmaceuticals (5.23x LTM Revenue, 17.6x LTM EBITDA)
 - > Life Science Conglomerates (3.79x LTM Revenue, 19.1x LTM EBITDA)

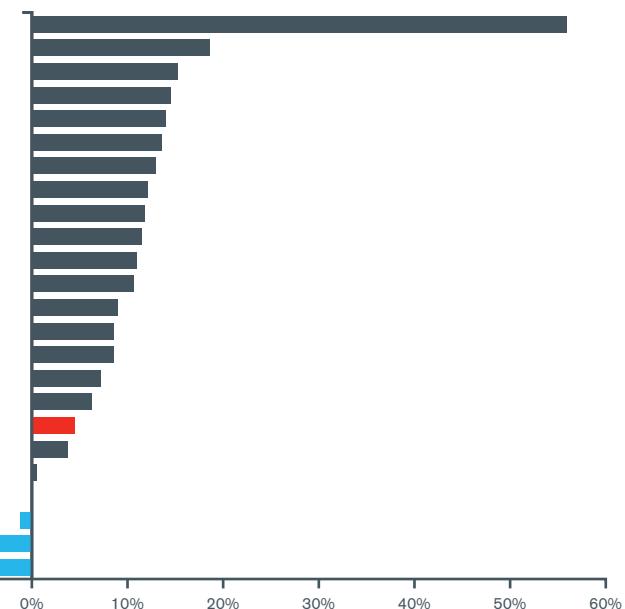

Median % Change – 3 months



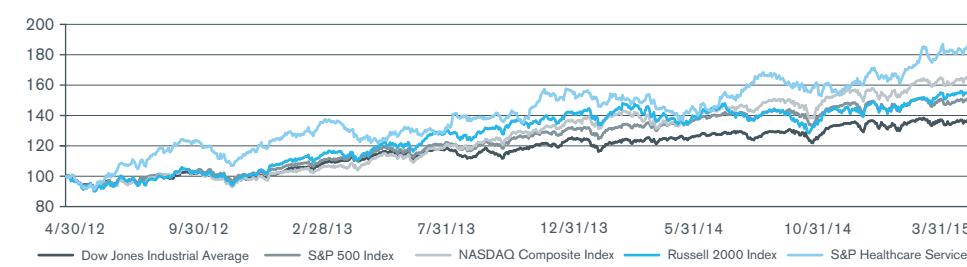

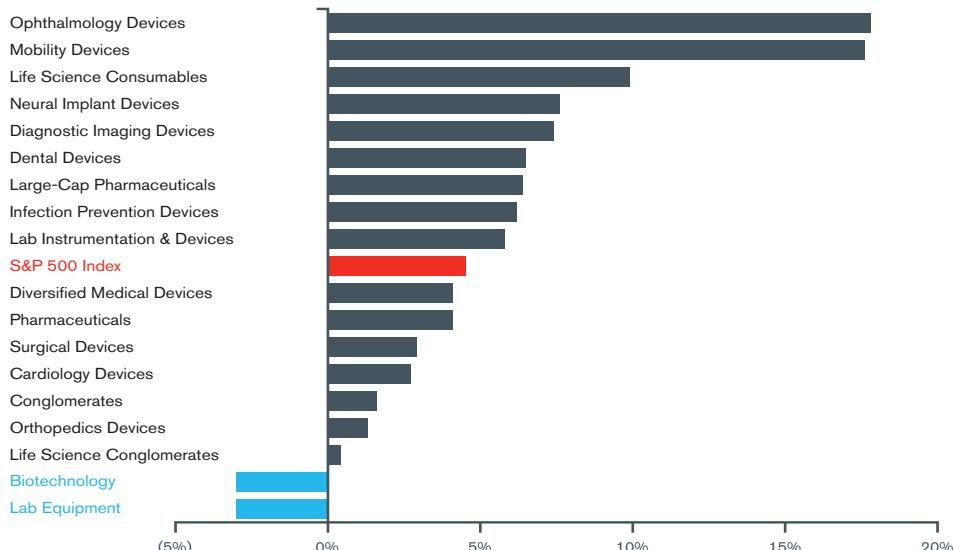

Median % Change – 3 months



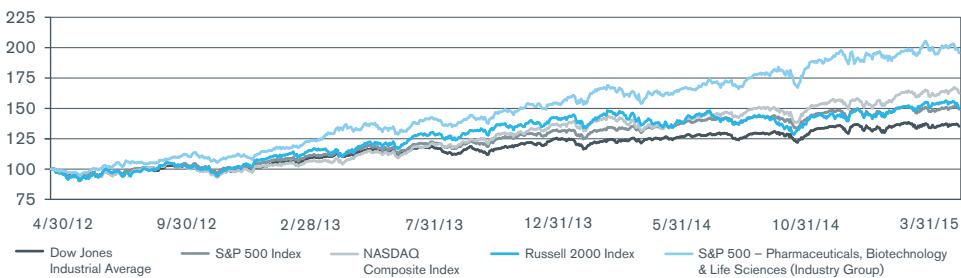
