6th Circular to Creditors

Dear Sirs,

Torque Group Holdings Limited (In Liquidation) ("Torque") BVI Company Registration Number: 2024611

I refer to the Circular dated 7 June 2021 ("5th Circular"), in which the Liquidators informed creditors of an application ("**OS 439**") filed by the Liquidators' Singapore counsel, Rajah & Tann Singapore LLP, in the Singapore High Court.

Unless otherwise defined herein, capitalized terms used in this circular shall have the same meanings as those defined in the 5^{th} Circular.

The purpose of this circular ("6th Circular") is to inform creditors of an application ("ORC 5699") filed by the Liquidators' Singapore counsel, Rajah & Tann Singapore LLP, in the Singapore High Court for orders which include the recognition of the substitution of the Joint Liquidator Philip John Smith by the Joint Liquidator Kent McParland.

This application was heard before Justice Vinodh Coomaraswamy who granted the order in the terms sought, with the substitution taking effect retrospectively from 7 July 2021, being the date of the substitution order in the BVI. A copy of ORC 5699 is enclosed below.
