

## **Supply Chain Networks After COVID-19**

COVID-19 will lead to significant change in global supply chains

- Bankruptcies and closures
- Changes in nature of current partners (downsizing, restructuring, M&A...)
- New ownership of existing partners
- Continued disruptions due to "second waves"
- Growing push to geographically diversify suppliers
- New pressures to "reshore" or "near shore"






Medical device supply chains also face unique challenges

- Significant quality issues
- Spike in fraud and corruption
- Hyper-demand volatility
- Confusing regulatory environment
- Global state-imposed trade guidance
- Growing US-China geopolitical competition

#### Fraud / Corruption in Medical Device Supply Chains

Medical device supply chains facing unprecedented fraud and corruption risks

- Result of significant gap between demand and supply, especially for PPE
  - WHO: global PPE production must grow by 40% to meet demand
- Government organizations, hospital systems and companies around the globe have fallen victim in recent months
  - Sellers, agents and manufacturers have all been variously involved

As a result, governments are prioritizing actions against these crimes

- DOJ / FBI, DHS, ICE, FDA, USPS investigations and screening efforts
- European Anti-Fraud Office (OLAF) investigations

#### **Impacts to the Medical Device Industry**

- Continued upheaval up and down supply chain
- Growing concern of counterfeit parts
- "Whiplash" due to frequent regulatory changes
- Need to rapidly pivot to alternate component suppliers
- Uncertainty of new, often unknown and untested suppliers
- Rise of regional "consortiums" to pool purchasing power



#### Order #5



Applies to exporting following medical supplies:

- 1. Test Kits
- 2. Ventilator
- 3. Medical Protective Clothing
- 4. Medical Protective Masks
- 5. Medical Surgical Masks
- 6. Disposable Medical Masks
- 7. Infrared Thermometer

4, 5 and 6 = what's difference? What about face shields?

Product must have PRC Medical Device Product Registration Certificate and comply with quality standards of importing country.

Beginning on April 10, China Customs started checking "medical supplies such as [cloth face masks]" for quality.

- 1. Medical Use Face Masks
- 2. Medical Use Protective Clothing
- 3. Infrared External Thermometers
- 4. Ventilators
- 5. Medical Use Surgical Caps
- 6. Medical Use Protective Goggles
- 7. Medical Use Gloves
- 8. Medical Use Shoe Covers
- 9. Patient Monitor
- 10. Medical Use Sanitary Wipes
- 11. Medical Use Disinfectant

This list is much broader than that in Order 5. Items 5 to 11 are not included in Order 5.

#### **April 25 Announcements**



China's General Administration of Customs (GAC) and its State Administration of Market Regulation (SAMR) issued announcement on quality controls for non-medical face masks, Medical Masks, Medical Protective Suits, Infrared Thermometers, Medical Ventilators, and COVID-19 Test Kits. Medical use products on a permitted list may be exported non-medical masks on a prohibited list cannot be exported.

#### **China Customs**

If you want PPE orders to get through China customs, be certain of the following:

- The company manufacturing your PPE product is licensed to make **and** export that product.
- Your paperwork is perfect.
- Your PPE product is of good quality and not counterfeit.
- Your PPE can be legally sent to *and* received at its intended destination.



#### Medical Device Supply Chains – Reacting to a Fluid Market

#### **Suppliers pivoting to PPE/Medical Device Production**

- » What did they do before?
- » Do they have a track record of producing at scale?
- » What is their reputation

#### Addressing risks for established companies

- » What is their reputation in the Medical Devices sector
- » What changes have they gone through as a result of COVID-19 do new risks present themselves?
- » Time to reassess their risk profiles

## Looking Beyond China....General Best Practice

#### **Red Flags to look out for:**

- How were they sourced / introduced?
- Unusual communication WhatsApp, personal email addresses
- No history in the medical devices / PPE sector
- Does not have a demonstrable track record / corporate footprint / public profile
- Cannot explain the origin of the equipment or how their availability given current demand
- Unwilling to or cannot demonstrate that the supply chain is legitimate
- If an intermediary, lack of existing relationship with the seller
- Last minute changes to payment instructions or recipients

#### Looking Beyond China....What's being done to combat PPE fraud

European Anti-Fraud Office (OLAF) has already identified over 340 companies acting as intermediaries or traders of counterfeit or substandard products linked to the COVID-19 pandemic.

The UK National Cyber Security Centre (NCSC) claims to have removed around 500 fake online shops selling fraudulent PPE.

The US authorities have initiated over 100 criminal investigations, and has prevented approximately \$1 billion in fraud.


